Poker Rules

The following specific terms and conditions (our "**Poker Rules**") govern Your use of all our interactive Poker products and services on the Service and form part of Your Agreement as set out in the T&C..

To the extent there is any inconsistency between the Terms and any of these Poker Rules, then the Terms shall prevail.

Poker store cash-ins

Any points not used within 6 months of being earned will be automatically removed.

Any players inactive for three months or more will have their points removed.

Disconnection – Cash Games

While playing at WinBet555 Poker, there are times when players may experience a delay or even be disconnected by the game server during a hand.

If this happens to a real money player at WinBet555 who has money in the pot, the player will be able to contact our Customer Service team and the hand will be reviewed. If it is determined that a player was disconnected with the winning hand due to an issue with the WinBet555 or network poker servers, a credit will be applied.

However if no issue is found with the WinBet555 servers no refund will be applied.

Disconnection – Single Table Tournament

If a Player is disconnected from the system during tournament play, the following rules apply:



If a Player is disconnected during the play of a hand and have placed a bet, they have thirty seconds to reconnect. If they do not reconnect within thirty seconds, the following happens:

- If the Player can check, their hand is automatically checked.
- If a player was already All-In before being disconnected, that status will not change and they will still collect their chips if they win the hand, or any portion of the pot.
- If the Player does not qualify to check their hand, or be considered All-In, their hand automatically folds.
- If the hand is raised then the player's hand is automatically folded.

Players that are disconnected and fail to return to the tournament are blinded-off.

Disconnection – Multi Table Tournament

If a Player is disconnected from the system during tournament play, the following rules apply:

If a Player is disconnected during the play of a hand and have placed a bet, they have thirty seconds to reconnect. If they do not reconnect within thirty seconds, the following happens:

- If the Player can check, their hand is automatically checked.
- If a player was already All-In before being disconnected, that status will not change and they will still collect their chips if they win the hand, or any portion of the pot.
- If the Player does not qualify to check their hand, or be considered All-In, their hand automatically folds.
- If the hand is raised then the player's hand is automatically folded.

Players that are disconnected and fail to return to the tournament are blinded-off.



Software Down Time – All Tables

WinBet555 regularly perform scheduled maintenance of our systems.

During these maintenance periods, activity at poker tables ceases and all games are stopped.

We notify players of impending "downtimes" with notifications via the software and through Customer Support.

Players can continue to play as normal until the maintenance period begins, wherein play is discontinued.

Players that are sitting at tables that are discontinued are therefore not entitled to lost bets or un-won prizes.

interrupted Tournaments Payout Policy

Both players receive a refund of buy-in + fee.

ALL SNG Tournaments

Eliminated players do not receive a refund.

Remaining players receive refund made up as follows:

1. Buy-in and Fee is returned.
2. Each player receives an equal share of the buy-ins from the eliminated players.

MTT Guaranteed Prize

The settlement is dependent upon what stage the T is at when it is interrupted:
Prize money stage not reached (if the tournament is still in the re-buy stage then the prize pool will be the total of the buy-ins + add-ons . Once the re-buy period has closed then the prize pool will be the advertised guaranteed prize).



Eliminated players do not receive a refund

Remaining players receive a refund made up as follows:

1. Buy-in(s) and fee returned
2. The balance of the prize fund is paid out as follows:
 - a. 50% of the fund shared equally among the remaining players
 - b. 50% distributed proportionally in line with the players chip counts.

Prize money stage has been reached

Eliminated players do not receive a refund

2. Each player is awarded an amount equal to the prize that the next eliminated player would have received if the tournament was not interrupted.
3. Of the remaining prize pool 50% is distributed equally among the players and 50% is distributed in proportion to their chip counts.

MTT No Guaranteed Prize:

Prize money stage not reached:

Eliminated players do not receive a refund

Remaining players receive a refund made up as follows:

1. Buy-in(s) and fee returned
2. The balance of the prize fund is paid out as follows:
 - a. 50% of the fund shared equally among the remaining players
 - b. 50% distributed proportionally in line with the players chip counts.

Prize money stage reached:

Eliminated players do not receive a refund

Remaining players receive a refund made up as follows:

1. Buy-in(s) and fee returned

Prize money stage not reached:

1. 50% of the fund shared equally among the remaining players
2. 50% distributed proportionally in line with the players chip counts.

Prize money stage reached:

1. Each player is awarded an amount equal to the prize that the next eliminated player would have received if the tournament was not interrupted.

LEGAL REQUIREMENTS

You are not using or intending to use or intending to allow any other person to use the Online Casino and the Player Account for any prohibited or unlawful activity, including but not limited to, fraud or money laundering, under any applicable law in particular your jurisdiction and the laws that apply to us;

you are not under the age of either (i) 18; or (ii) the age at which gambling activities are legal under the law of the jurisdiction that applies to you, whichever is greater;

the debit/credit card details supplied by you in the registration process are those of the registered account holder and the card has not been reported as lost or stolen;

you are not one of our officer, director, employee, consultant or agent or of one of our affiliated or subsidiary companies, or suppliers or vendors, and you are not any of their relatives as well (for the purpose of this clause, the term "relative" means spouse, partner, parent, child or sibling). In any event that you have breached this prohibition, among others actions that will be taken against you, you will not be entitled to any of your winnings.



you have not previously held a Player Account which was suspended or terminated either by us or by any other online gaming operator, charged back any monies via a Player Account or maintains a current Player Account; and in opening the Player Account you will not provide any information or make any statement to us which is untrue, false, incorrect or misleading.
